We Can Do Better: An Example of Why Advocating for People Living with Dementia is an Imperative

A recent article reminded me again about the importance of being an advocate for people living with dementia. Avanir, a large pharmaceutical



Anne Ellett, MSN, NP, Green House Dementia Specialist company is required to pay millions of dollars to resolve Federal allegations that they had paid kickbacks and marketed their drug Neudexta to nursing homes for the off-label use of treating "behaviors" associated with dementia. Neudexta is a medication prescribed for a rare condition, PseudoBulbar Affect (PBA), that is unrelated to



dementia. Yet physicians and other healthcare providers prescribed this risky medication to frail older adults living in long term care. It's a reminder that all of us can play the important role of advocacy for persons living with dementia. Their actions are not "behaviors" but communication from them about the quality of their day. If they cannot verbally express their needs and desires and discomforts, they may exhibit actions we don't always understand. Let's take time to listen and learn and do no harm.
